WHAT IS AN ENROLLED AGENT?

An enrolled agent (EA) is a federally licensed tax practitioner who has proven technical expertise in the field of taxation. Enrolled agents are empowered by the U.S. Department of the Treasury to represent taxpayers before all administrative levels of the Internal Revenue Service (IRS). Only EAs, attorneys, and certified public accountants (CPAs) may represent taxpayers before IRS.

Enrolled Agents have demonstrated expertise in the field of taxation to the Internal Revenue Service after successfully sitting for the challenging 3-part Special Enrollment Examination and background investigation.

I was admitted to practice before the IRS as an Enrolled Agent effective March 14, 2011.

Directions to the Office

From the South: (Erie County & Niagara Falls)

I-190 North to Exit 25A/Military Rd-turn left.

Pass Mt. St. Mary's Hospital/right on Rt. 104.

Down Lewiston Hill, do not exit; continue to Robert Moses Pkwy/Fort Niagara.

Turn left after taking next exit, Pletcher Rd.

Turn right on Lower River Rd, look for the first house on right, brick one story next to the Senior Center.

From the East: (Lockport)

West on Rt. 104 to Lewiston/R. Moses Pkwy

North on Robert Moses Pkwy to Pletcher Rd.

Left after taking next exit, Pletcher Rd.

Turn right on Lower River Rd, look for the first house on right, brick ranch next to Senior Center.

Drop Box: Side Door Garage.

Appointments: Walk in through the garage to the basement office.
